### REGISTRATION

- Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (<u>URL:http//eprocure.gov.in/eprocure/app</u>) by clicking on the link "Online Bidder Enrolment" on the CPP Portal which is free of charge.
- 2) As part of the enrolment process, the Bidders will be required to choose a unique username and assign a password for their accounts.
- 3) Bidders are advised to registration process. These would be used for any communication from the CPP Portal.

- 1) Bidder should take into account any corrigendum published on the tender document before submitting their Bids.
- Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the Bid.
