NOTIFICATIONS.

No. 1617T.G.—The 18th August 1913.—Mr. T. O. D. Dunn, on special duty in the office of the Director of Public Instruction, **Calcutta.** Bengal, is allowed privilege leave for three months, under article 260 of the Civil Service Regulations, with effect from the 14th August 1913, or any subsequent date on which he may avail himself of it.

No. 4096.—The 19th August 1913.—In exercise of the power conferred on him by section 4 of Act V (B. C.) of 1881, His **Calcutta.** Excellency the Governor is pleased to nominate Mr. S. W. Goode, I.C.S., Chairman of the Corporation for the town of Calcutta, to act as Chairman of the Christian Burial Board for the town and suburbs of Calcutta, *vice* the Hon'ble Mr. S. L. Maddox, C.S.I., I.C.S., resigned.

No. 4063.—The 18th August 1913.—The Notification No. 3053, dated the 6th June 1913, published in the *Calcutta Gazette* of the 11th June 1913, which declared the five ancient monuments in the town of Vishnupur in the subdivision of the district of **Bankura.** Bankura, to be protected monuments, is confirmed under section 3 (3) of the Ancient Monuments Preservation Act, 1904 (VII of 1904).

No. 4092.—The 19th August 1913.—The notification No. 3097 dated the 16th June 1913, published in the *Calcutta Gazette* of the 18th June 1913, which declared the group of temples known as Brindaban Chandra's Math, which are situated in the village of Guptipara, in the district of Hooghly, to be protected monuments, is confirmed under section 3 (3) of the Ancient Monuments Preservation Act, 1904 (VII of 1904). **Hooghly.**

No. 4100.—The 19th August 1913.—In exercise of the powers conferred by section 11 of the Bengal Mining Settlements Act, 1912 (Bengal Act II of 1912), the Governor in Council is pleased to make the following rules for carrying out the purposes and objects of that Act in respect of all mining settlements and certain groups or classes of mining settlements in the Presidency of Fort William in Bengal.

Rules.

PART I.

RULES FOR THE NOMINATION BY OWNERS OF MINES OR THEIR REPRESENTATIVES OF PERSONS TO BE APPOINTED TO A MINES BOARD OF HEALTH UNDER SECTION 3 (2) OF BENGAL ACT II OF 1912.

Definitions.

1. In these rules:—

- (a) the expression "Magistrate" means the Magistrate of the district and includes a Deputy Commissioner of a district;

or crowded together, or of the want of drainage and the impracticability of scavenging, attended with risk of disease to the inhabitants of the neighbourhood, they may cause the locality to be inspected by two Medical Officers, who shall make a report in writing on the sanitary condition of the said block of huts; and shall specify, if necessary, in the said report, the huts which should be removed, the roads, drains, and sewers which should be constructed and the low lands which should be filled up, with a view to the removal of the said risk of disease.

59. On receipt of the said report, the Board may require the owners or occupiers of the huts, or at the option of the Board, the owner of the land on which such huts are built, to carry out and execute, within a reasonable time, to be fixed by the Board for such purpose, all or any of the works specified in the aforesaid report or any portion thereof respectively, and if such owner, owners or occupiers shall fail to comply with such requisition, the Board itself may execute all or any of such works.

60. Every owner, or occupier, or farmer, of any place for the sale of meat, poultry, fish or vegetables, or of any slaughter-house, within the limits of the mining settlement shall cause such drains to be made therein as shall be considered sufficient by the Board and (if required so to do by the Board) shall cause all the floors and drains to be paved with stone or burnt brick, and shall also cause a supply of water to be provided, sufficient for keeping such place or slaughter-house in a clean and wholesome state.
